The Chairman and Managing Director, Kovai Medical Center and Hospital, Coimbatore in his letter dated 11.05.2018 had forwarded the "Essentiality Certificate" issued by the State Government in Lr.(4D) No. 5/MCA-2/2018 dated 16.05.2018, Health & Family Welfare Department, Chennai for the purpose of establishing a new Medical College at Avinashi Road, Coimbatore, in the name and style as "**KMCH Institute of Health Sciences and Research**" with an annual intake of **150 seats** and the Chairman and Managing Director, Kovai Medical Center and Hospital, Coimbatore has requested to issue "Letter of Consent of Affiliation".

In the reference 3rd cited, an Inspection Commission was appointed by the University to verify the infrastructure and teaching faculties available at “ **KMCH Institute of Health Sciences and Research, Coimbatore** ” for issuing Letter of Consent of Affiliation for starting of 1 MBBS Degree Course for 150 seats . The Inspection Commission has conducted inspection on 13.06.2018 and submitted their report to this University.

In the reference 4th cited, based on the inspection report, “Letter of Consent of Affiliation” was issued to the Chairman and Managing Director, Kovai Medical Center and Hospital, Avinashi Road, Coimbatore vide this University's letter dated 29.06.2018 to start a new Medical College in the name and style as “ **KMCH Institute of Health Sciences and Research, Avinashi Road, Coimbatore** ” with an annual intake of 150 seats to apply to the Government of India for obtaining their prior permission for starting of the said course of study.

In the reference 5th cited, the Chairman and Managing Director of the above institution has requested to issue Provisional Affiliation orders for starting the MBBS Degree Course.

In the reference 6th cited, the Board of Governors in supersession of Medical Council of India, New Delhi had conveyed its formal permission of the Board of Governors for establishment of a new medical college at Coimbatore, Tamil Nadu in the name and style of “ **KMCH Institute of Health Sciences and Research, Tamil Nadu** ” with annual intake of 150 MBBS students for the academic year 2019-2020 under Section 10A of the Indian Medical Council Act, 1956.

In the reference 7th cited, based on the approval of the Board of Governors in supersession of Medical Council of India, New Delhi, an Inspection Commission has been constituted by this University and the inspection team has inspected the college on 29.05.2019 and submitted reports to this University for considering the grant of **Provisional Affiliation** for establishment of a new Medical College in the name of “ **KMCH Institute of Health Sciences and Research, Avinashi Road, Coimbatore** ” with an annual intake of 150 seats for the academic year 2019 -2020.

Based on the approval granted by the Board of Governors in supersession of Medical Council of India, New Delhi and in pursuance of the report of the Inspection Commission and the undertaking submitted by the Chairman and Managing Director of the above said institution, this University grants “ **Provisional Affiliation** ” for starting of 1st MBBS Degree Course at “ **KMCH Institute of Health Sciences and Research, Avinashi Road, Coimbatore** ” with an annual intake of 150 (One Hundred Fifty Only) student's for the academic year 2019-2020 subject to the conditions given in the annexure to this order.

ANNEXURE-I

The Provisional Affiliation is granted subject to the following conditions :

i.	The sanctioned strength for the MBBS Degree Course is 150 (One Hundred and Fifty only) from the academic year 2019 - 2020 . The maximum number of students that may be admitted to the course shall not exceed the sanctioned strength.
ii.	The admission procedure as enunciated by the Supreme Court of India, shall be followed.
iii.	The admission procedure as laid down in Government order should be followed. Any admission made over and above will not be permissible on any account.
iv.	" KMCH Institute of Health Sciences and Research, Avinashi Road, Coimbatore " shall abide by the provisions of the Tamil Nadu, Dr. M.G.R. Medical University Act, 1987 (Tamil Nadu Act 37 of 1987) and by Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the medical colleges framed from time to time.
v.	Only eligible candidates according to the regulations of this University shall be admitted to the first year MBBS Degree Course for the academic year 2019 - 2020 . While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly.
vi.	The candidates should be admitted in the capacity of 150 seats before the prescribed cut off date for MBBS Degree Course and they will be registered to take up their I st Year examination as per existing regulations. There will not be any admission after 31 st August.
vii.	The Institution should undertake to abide by the provisions of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) and by the Statutes, Ordinance, Regulations and Rules of the Tamil Nadu Dr. M.G.R. Medical University applicable to the Medical Colleges framed from time to time.
viii.	The conditions that may be prescribed by the Medical Council of India shall be fulfilled. The standard and requirement prescribed by Medical Council of India from time to time for admission to Medical Colleges shall be followed strictly.
ix.	The College shall abide by any other conditions which the University may consider necessary and impose from time to time.
x.	Only qualified staff shall be appointed to handle the classes. No unqualified staff shall be appointed.
xi.	Only eligible candidates according to the regulations of this University shall be admitted.
xii.	While making admission, the rule of reservation of the Government of Tamil Nadu shall be adopted strictly.
xiii.	The Institution shall obtain the recognition of the Medical council of India for 150 seats and submit the copy of the same to this University.

xiv.	The Institution shall furnish a budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the entire course of study.
xv.	The staff, student ratio prescribed by the Medical council of India shall be followed. The staff pattern with prescribed qualification by the University as well as the Medical Council of India should be followed.
xvi.	The Institution shall obtain the renewal permission of the Government of India for an intake of 150 seats every year and submit the copy of the same to the University.
xvii.	Hostel accommodation shall be made available for the students.
xviii.	Required furniture shall be provided wherever they are necessary.
xix.	There shall not be any financial commitment either to this University or to the Government.
xx.	Furnishing of false information to the University any matter or suppression of facts while furnishing information to the University or violation of any of the Statues, Ordinances, Regulations, Rules, Instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
xxi.	The Institution shall furnish all the teaching and other staff details with qualification, experience, date of joining etc., whenever required by the University.
xxii.	The course should be conducted to accordance with the regulation and syllabus approved by this University and Medical Council of India.
xxiii.	Facilities should be made available for conducting University Examinations.
xxiv.	The Medical College shall have a duly constituted Governing body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.
xxv.	The Governing Body of the college shall meet atleast once in every three months to consider the budget estimate and such other matters as may arise in its working. It shall meet in May-June each year to consider the Annual Report, the audited statement of accounts, changes in the staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year.
xxvi.	The Security Deposit of Rs.40,00,000/- (Rupees Forty Lakhs) each for the Second and Third installment should be created and submitted to this University during 2 nd and 3 rd year.
xxvii.	After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University (Affiliation of Medical Colleges) Statutes, by the end of 1 st year MBBS Degree Course of Study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the Second year MBBS Degree Course of study.
xxviii.	The candidates should be admitted before the cut off date i.e., 31 st August fixed for all the institutions, which are running MBBS Degree Courses.
xxix.	During the University Examinations, the question paper will be sent through inter net for which the following equipments have to be purchased and kept ready by the Institution.
