Degree Course with an annual intake of 150 seats.

2. In the reference 3rd cited, this University has granted Provisional Affiliation orders to **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014** for the starting of MBBS Degree Course with an annual intake of 150 students from the academic year 2019-2020, as per the approval granted by the Medical Council of India.

3. In the reference 4th cited, this University has granted Conditional Continuance of Provisional Affiliation orders to **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014** for conducting 1st, 2nd, 3rd, 4th & 5th Batch of MBBS Degree Course with an annual intake of 150 seats for the academic year 2023-2024, subject to the condition that the said institution has to submit Bank Guarantee and assurance to redeem the mortgage properties.

4. In the reference 10th cited, the Government of India, National Medical Commission (Under Graduate Medical Education Board), New Delhi in its Public Notice, granted permission to the said institution for 150 MBBS Seats for the academic year 2024-2025.

5. The Seat Matrix for M.B.B.S. Degree Course for 150 seats was also informed to the Selection Committee for the academic year 2024-2025.

6. The Dean, **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014** has remitted the required fee in the above said course for the academic year 2024-2025 through online RTGS / CMS2 portal.

The Institution has submitted the compliance rectification report, uploaded documents in CMS-2 Portal and further, Inspection Team has been conducted the inspection one day on 26.06.2024 and submitted its report on the infrastructural, teaching and other facilities available at **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014** for the grant of Conditional Continuance of Provisional Affiliation for conducting M.B.B.S. Degree Course with an annual intake of 150 seats for the academic year 2024-2025.

In pursuance of the Renewal of Permission granted by the Government of India, National Medical Commission (UGMEB), New Delhi, report submitted by the Inspection Team, **this University hereby grants the orders of Conditional Continuance of Provisional Affiliation to KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014 for conducting entire M.B.B.S. Degree Course with an annual intake of 150 seats for the academic year 2024-2025**, subject to the following conditions:-

- i) To submit the Bank Guarantee and assurance to redeem the mortgage properties;
- ii) To fulfil all the requirements (infrastructural, teaching and other facilities available) in the CMS2.0 portal;
- iii) To abide the prescribed Rules/Guidelines of the Statutory bodies/Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time;
- iv) The University may conduct inspection to verify the above if required and
- v) The usual conditions already intimated in the Provisional Affiliation orders of this University.
