#### PREAMBLE:-

In the reference 1<sup>st</sup> cited, Kovai Medical Center and Hospital Ltd., Avanashi Road, Coimbatore – 641 014 has obtained Government Order from Health and Family

Welfare Department, Secretariat, Chennai, Tamil Nadu for the purpose of establishing a new Medical College in the name and style of **KMCH Institute of Health Sciences and Research**, No. 99, Avanashi Road, Coimbatore – 641 014 to conduct M.B.B.S. Degree Course with an annual intake of 150 seats.

- 2. In the reference 3<sup>rd</sup> cited, this University has granted Provisional Affiliation orders to **KMCH Institute of Health Sciences and Research**, **No. 99**, **Avanashi Road**, **Coimbatore 641 014** for the starting of MBBS Degree Course with an annual intake of 150 students from the academic year 2019-2020, as per the approval granted by the Medical Council of India. The same was approved in 271<sup>th</sup> Governing Council Meeting held on 12.09.2019.
- 3. In the reference 4<sup>th</sup> cited, this University has granted Conditional Continuance of Provisional Affiliation orders to **KMCH Institute of Health Sciences and Research**, **No. 99, Avanashi Road, Coimbatore 641 014** for conducting MBBS Degree Course with an annual intake of 150 seats for the academic year 2020-2021, subject to the condition that the said institution has to submit the Bank Guarantee and also to submit assurance to redeem the mortgage properties within a period of 5 years.
- 4. In the references 6<sup>th</sup> and 12<sup>th</sup> cited, the National Medical Commission, New Delhi has granted Second (3<sup>rd</sup> Batch) & Third (4<sup>th</sup> Batch) Renewal of Permission to **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore 641 014** for conducting MBBS Degree Course for 150 seats for the academic year 2021-22 & 2022-23.
- 5. The Seat Matrix was also informed to the Selection Committee for the academic years 2021-22 and 2022-23 for M.B.B.S. Degree Course.
- 6. The Dean, KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore 641 014 has remitted the required fee in the above said course for the academic year 2021-22 & 2022-23 through online RTGS / CMS2 portal.
- 7. Based on the Resolutions passed at the Governing Council Meeting in the references 7<sup>th</sup> & 10<sup>th</sup> cited, the Institution has been instructed to upload the necessary documents in the Affiliation Module of CMS-2 portal and further, the inspection was conducted by the Inspection Team on 06.04.2023 and submitted its report on the infrastructural, teaching and other facilities available at **KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore 641 014** for grant of Conditional Continuance of Provisional Affiliation for conducting M.B.B.S Degree Course for the academic years 2021-22 & 2022-23.

#### ORDER:

In pursuance to the Resolutions passed by the Governing Council, Renewal of Permission granted by National Medical Commission, New Delhi, inspection report submitted by the Inspection Team, data uploaded in the CMS2 portal and receipt of the required fee, this University hereby grants the orders of Conditional Continuance of Provisional Affiliation to KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore – 641 014 for conducting M.B.B.S. Degree Course with an annual intake mentioned against for the academic year 2021–2022 & 2022-23, subject to the following conditions:-

- i) the usual conditions already intimated in the Provisional Affiliation Orders of this University;
  - ii) submit the Bank Guarantee and assurance to redeem the mortgage properties;
- iii) to fulfill all the requirements (infrastructural, teaching and other facilities available) in the CMS2.0 Portal;
- iv) to rectify any other deficiencies pointed out in the report of the Inspection Commission and data submitted in the portal;
  - v) the University may conduct inspection to verify the above if required and
- vi) to abide the prescribed Rules / Guidelines of the Statutory bodies / Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time;
