Degree Course with an annual intake of 150 seats.

- 2. In the reference 3rd cited, this University has granted Provisional Affiliation orders to KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore - 641 014 for the starting of MBBS Degree Course with an annual intake of 150 students from the academic year 2019-2020, as per the approval granted by the Medical Council of India.

In the reference 4th cited, this University has granted Conditional Continuance of Provisional Affiliation orders to KMCH Institute of Health Sciences and Research, No. 99, Avanashi Road, Coimbatore - 641 014 for conducting 1st, 2nd, 3rd & 4th Batch of MBBS Degree Course with an annual intake of 150 seats for the academic year 2021-2022 & 2022-2023, subject to the condition that the said institution has to submit Bank Guarantee and assurance to redeem the mortgage properties.

Degree Course with an annual intake of 150 seats for the academic year 2023-2024.

Degree Course with an annual intake of 150 seats for the academic year 2023-2024, subject to the following conditions:-

- i) To submit the Bank Guarantee and assurance to redeem the mortgage properties;
- ii) To fulfil all the requirements (infrastructural, teaching and other facilities available) in the CMS2.0 portal;
- iii) To rectify any other deficiencies pointed out in the report of the Inspection Commission and data submitted in the portal;
- iv) To abide the prescribed Rules/Guidelines of the Statutory bodies/Government of Tamil Nadu and the Affiliation Statutes of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, imposed from time to time;
 - v) The University may conduct inspection to verify the above if required and
 - vi) The usual conditions already intimated in the Provisional Affiliation orders of this University.
